from west boundary Lot 1547

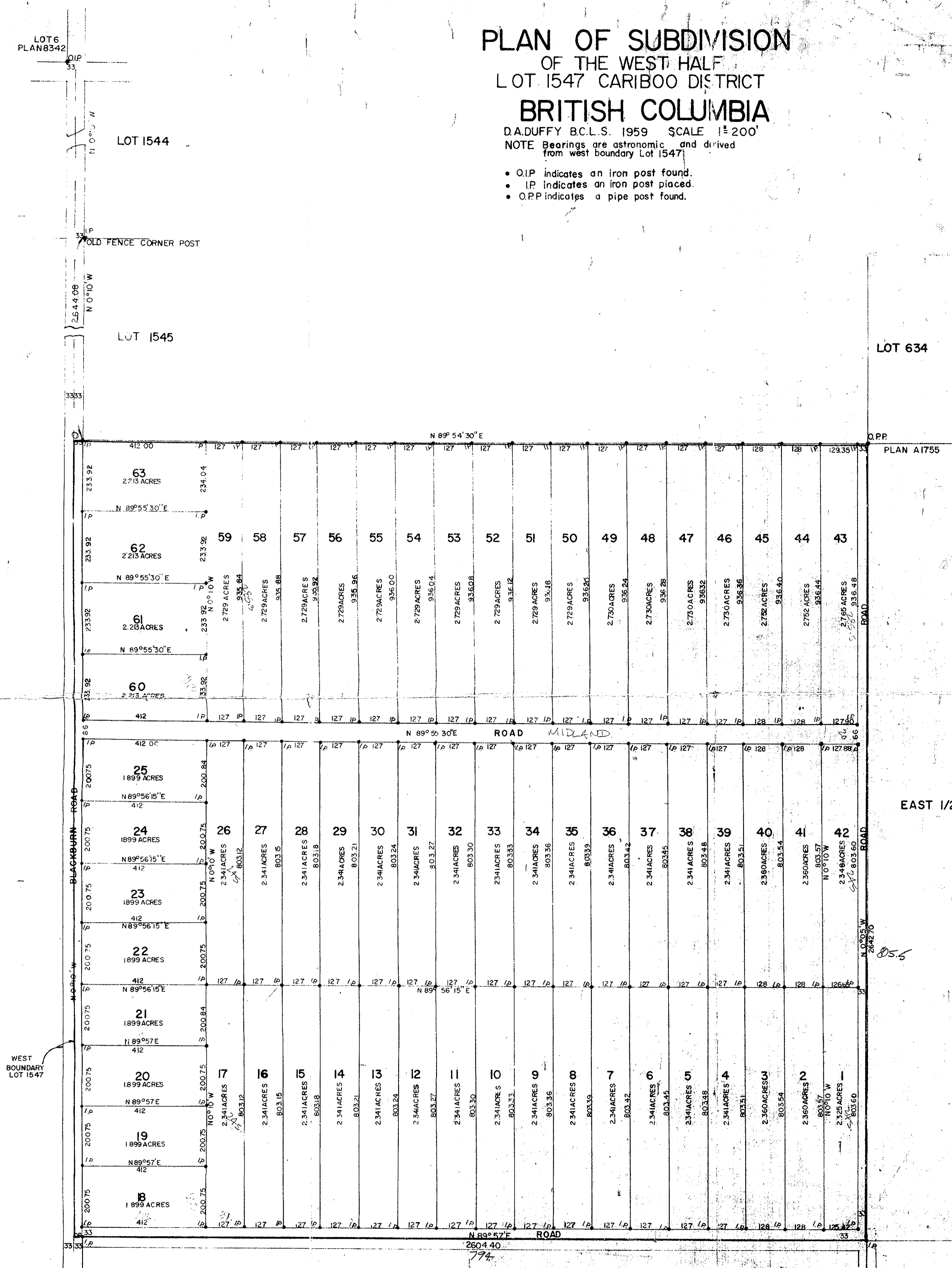
